2. The renewal fee for a certificate of registration or a certificate to practice as a landscape

architect intern will be prorated on a monthly basis for each month after July 1 that the

renewal fee is submitted.

Change the wording in NAC623A.513.1 to strike designated member of the board and replace with Executive Director. Presented here:

NAC 623A.513 Complaints against certificate holders: Public meeting of the Board; dismissal; preparation and service of formal disciplinary complaint and notice of hearing. (NRS 623A.130)

1. At a public meeting of the Board, the Board will review the recommendation of the designated member of the Board Executive Director on a complaint provided pursuant to the provisions of <u>NAC 623A.511</u> and decide whether to:

(a) Dismiss the complaint; or

(b) Proceed with a formal disciplinary hearing on the complaint and fix a date for the hearing on the matter.

**3.** The estimated economic effect of the regulation on the business which it is to regulate and on the public. (These must be stated separately and in each case must include:)

(a) Both adverse and beneficial effects; and

The economic effect of increasing fees may be an increase in the cost of licensure to the professional if/when the fees are increased by the board to provide the level of service that the licensees are used to. The economic effect to the public may be slight increase in the fees charged by the professional as a part of the overhead cost of doing business. As for the changing of the designation for disciplinary complaint, there is no economic

effect on the public. The economic effect upon NRS Chapter 623A licensees is limited to compliance-related issues typically limited to adjudication hearing, as the full board may hear the complaint.

(b) Both immediate and long-term effects.

There is no immediate effect on the professionals or the public. The board may in the future raise the fees in accordance with standard economic indicators.

As for the changing of the designation for disciplinary complaint, the is no immediate or long-term effect, it would depend on the number of complaints being processed. This is expected to reduce the cost and time of regulatory investigations and adjudication of licensees.

## **4.** The estimated cost to the agency for enforcement of the proposed regulation. Cost to the agency should be minimal.

# 5. There are no overlapping or duplicate regulations from local, state or federal agencies.

The proposed regulation does not overlap or duplicate any regulation.

**8.** Whether proposed regulation establishes a new fee or increases an existing fee. The proposed amended regulation NAC623A.240 increases existing fees as approved by 2019 legislature.
